CLASSES AND EVENTS WAIVER, RISK, LIABILITY RELEASE, INDEMNITY and HOLD HARMLESS AGREEMENT

PLEASE READ CAREFULLY BEFORE SIGNING THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.

The person who is participating in the Classes and Events: Martial Arts, Taekwondo, Tang Soo Do, Hapkido, Karate, Tournament, Testing, Self Defense, Class, Breaking, Enrichment, Forms, Demonstration, Tiger Kim's Academy, AAU, Costa, and other Championships shall be referred to hereinafter as "PARTICIPANT" "THE UNDERSIGNED" means only the PARTICIPANT when the PARTICIPANT is age 18 or older OR it means both the PARTICIPANT and the PARTICIPANT'S parent or legal guardian when the PARTICIPANT is under age 18. THE UNDERSIGNED agree and understand that the Martial Arts, Taekwondo, Tang Soo Do, Hapkido, Karate, Tournament, Testing, Self Defense, Class, Breaking, Enrichment, Forms, Demonstration, Tiger Kim's Academy, AAU, Costa, and other Championships or any of them, (Hereinafter the "ACTIVITY") can be HAZARDOUS AND INVOLVE THE RISK OF PHYSICAL INJURY OR DEATH.

THE UNDERSIGNED further AGREE TO DEFEND AND INDEMNIFY each RELEASED PARTY for any other claims of THE UNDERSIGNED and/or a THIRD PARTY arising in whole or in part from the PARTICIPANTS'S participation in the ACTIVITY. THE UNDERSIGNED agree to pay all costs and attorney's fees incurred by any RELEASED PARTY in defending a claim or suit brought by or on behalf of THE UNDERSIGNED.

By Signing this release, the PARTICIPANT represents that/she is at least 18 years of age. or if signing as the parent or guardian of the PARTICIPANT, you represent that you are the legal parent or guardian of the minor PARTICIPANT AND ACCEPT FULL RESPONSIBILITY.

This release shall be binding to the fullest extent permitted by law.
